Opportunities for international trade in 2022

Lead Speaker: Andrew Mitchell, Director General, Exports and UK Trade, Department for International Trade

One argument for Brexit was to enable the UK to pivot from focusing on the EU market, which is shrinking as a proportion of total world trade, to international markets that are growing. To help businesses and the economy to take advantage of new opportunities, the Government has concluded new trade agreements and worked on other initiatives to promote trade. Individual companies have also adapted their own business strategies. This policy roundtable will be led by Andrew Mitchell, DG, Exports and UK Trade at the department of trade who will outline what the Government is doing and progress to date. A small panel will respond and comment, followed by questions and answers from the invited business audience.

Helping UK Energy-Intensive Industries

Lead Speaker: Bill Esterson MP, Shadow Minister (Business and Industrial Strategy)

Industries like steel, cement and ceramics are the bedrock of UK manufacturing industry. It is impossible to conceive of a successful UK manufacturing revival dependant on importing their products. But these industries consume enormous amounts of energy currently provided by fossil fuels, and this is the source of two enormous problems. The first is how to remain competitive while still relying on fuels whose prices have risen dramatically. The second is how to transition to sustainable and affordable renewable energy, like hydrogen. Other manufacturing nations are providing quite a lot of help to their energy-intensive industries; it is clear that the UK needs to do the same. Bill Esterson MP, Shadow BEIS minister, will lead a discussion, with a panel of industry specialists, about the policies and practical actions that are urgently needed.
